

### April 17 auction will benefit Black Forest recovery and restoration

Black Forest Together has received a generous donation of new items, which will be auctioned to raise funds to support fire recovery and forest restoration work.

A wide variety of new household and office goods will be included in the regular weekly auction at Ross Auction, at 815 S. Sierra Madre (downtown). The **Friday, April 17** auction begins at noon; items can be inspected beginning at 8:30 am. To learn what items will benefit Black Forest Together, simply ask the Ross Auction staff.

This auction will take place on Friday, April 17 only. (This is a change from our original announcement.)

The items to be auctioned were recovered by the Colorado Springs Police Department (CSPD) during an investigation and subsequent prosecution of a large retail theft ring. The items were stolen from retail stores and are in new condition.

Safeway, through the efforts of Nathan Bandaries, Senior Investigator for Safeway's Organized Retail Crime Division, supplied and paid for a semitrailer to store the items as well as a commercial driver to move the trailer from location to location. An exhaustive inventory of the items was completed by CSPD Evidence Technician Shirley Milligan.

When it was clear that the remaining items could not be returned to the retail centers, officials of the 4th Judicial District Attorney's Office in cooperation with the defense attorneys, thought of a solution that would benefit the community. They donated the entire lot to Black Forest Together, Inc., to raise funds to support the Black Forest community's ongoing recovery from the wildfire of 2013.

### Seedling tree pickup instructions

If you have already reserved seedlings, here's when and where to pick them up:

Date: Saturday, May 9, 2015Time: 9:00 am to 3:00 pm

Place: Black Forest Fire Station 2 on Ridge Run Road (at the corner of Hodgen Road).

Trees MUST be picked up at that time. If you cannot pick up your trees during those hours, you must make arrangements for someone else to pick them up for you. We do not have facilities to store the trees. Seedling orders not picked up by 3:00 pm will be considered abandoned. All abandoned trees will be given away from 3:30 to 5:00 pm. This is a first-come, first-served giveaway, but each household is limited to 50 trees.

This tree giveaway has been made possible by generous support from the Arbor Day Foundation, FedEx, the National Wildlife Federation, and the Colorado State Forest Service. A total of 10,000 free tree seedlings, in five species, has been donated to restore land that was burned by the Black Forest Fire of 2013. These trees have been grown by the Colorado State Forest Service, and are well suited to our area.

#### New help is available for fire-affected businesses

New grant funding is available to help businesses and non-profits that were impacted by the Black Forest Fire, or by the floods of September 2013. The Recover Colorado Business Grant and Loan program has received a second round of funding to meet needs that have not been addressed through other sources of public and private assistance (such as the Federal Emergency Management Agency and Small Business Administration).

Applications for this program are now available. The application deadline is July 31, 2015.
